ARTICLES OF INCORPORATION SEC. OF STATE

The Canyon County Coalition on A Fig. 8 56 A Mon-profit Corporation

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are of full age and citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under and pursuant to Chapter 110, Title 30 of the Idaho Code, and we do hereby certify.

ARTICLE I

The name of the Corporation shall be The Canyon County Coalition On Crime Inc.

ARTICLE II

Subject to dissolution in the manner provided by law, the duration of the Corporation shall be perpetual.

ARTICLE III

The purposes for which this corporation is formed are;

- 1) To coordinate to the maximum extent feasible the efforts of all entities involved in crime prevention and law enforcement, providing a forum for same to plan, pool resources and develop common directions
- 2) To initiate programs designed to assist in the law enforcement/crime prevention efforts and to oversee their implementation and operation.
- 3) To encourage its citizenry to become involved in prevention activities and assist in such involvement through direction and encouragement.
- 4) To act as an information and referral source to those in need of help, directing each to an appropriate program or service.
- 5) To raise funds to support law enforcement/ crime prevention activities and distribute accordingly.
- 6) To act as an educational resource to the community, providing seminars, training sessions, informational gathering and the like.
- 7) To offer support to law enforcement agencies and units of government in the way of model systems, analysis of models of operation and general consultation.
- 8) To be involved in community activities not directly tied to law enforcement/crime prevention but which have potential to bolster such efforts.
- 9) For the accomplishment of the aforementioned purposes, the Corporation may:
 - a) Receive monies, equipment, property or labor from

any source including, but not limited to private sources, governmental sources or whatever, and purchase, convey, mortgage and lease, all kinds or real personal property or otherwise use the funds.

- b) Borrow money and draw, make, accept, endorse, assign, guarantee, execute and issue notes, checks, drafts, bonds, debentures, negotiable instruments and other instruments for the payment of money and mortgage or pledge its property to secure such obligations.
- c) Loan money and accept notes, checks, drafts, bonds, debentures, negotiable instruments and other instruments for the payment of money and receive mortgages or pledges of property to secure each obligations accepted.
- 10) To do all things necessary, essential, convenient, or proper for the accomplishment of any and all of the aforementioned purposes for the attainment of any and all of the objects above mentioned, incident to the powers herein named, or which shall have at any time appeared to be conclusive or expedient or beneficial to the corporation, and to such end to have any and all powers conferred upon non-profit cooperative associations and corporations organized under the statutes of the State of Idaho as now constituted and as may be provided by future thereto.
- 11) To exercise and perform all of the above described powers both within and outside the State of Idaho.

ARTICLE IV

This corporation is organized exclusively for charitable, educational, and scientific purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of the future United States Internal Revenue law).

ARTICLE V

The principal place of business of this corporation shall be at Caldwell, County of Canyon, State of Idaho. That the address of the initial registered office is 300 Frontage Road, Idaho 83605. The initial registered agent is Robert N. Jarboe, President/CEO.

ARTICLE VI

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for the services rendered to and make payments and distributions in furtherance of the purposes set forth in Article III and IV hereof. No substantial part of the activities of the corporation shall be the publishing or distribution of statements, in any

political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, engage in any activities or exercise any powers that are not in the furtherance of the purposes of this corporation.

ARTICLE VII

Upon the dissolution of the corporation, the board of directors shall, after paying of making provisions for the payment of all the liabilities of the corporation, dispose all assets of the corporation exclusively for the purposes of the corporation in such a manner, or to such organization or organizations organized and operated exclusively for charitable, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law), as the board of directors shall determine. Any of such assets not so disposed of shall be disposed of the District Court of the State Judicial District of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated for the above mentioned purposes.

ARTICLE VIII

The rights and interests of all members of this corporation shall be equal and no member shall have or acquire a greater interest than any other member. This corporation shall not issue capital stock, but shall issue membership certificates to each member thereof, which certificates cannot be assigned so that the transferee thereof can by such transfer become a member of the association, except by as resolution of the board of directors and under such regulations as the by-laws of this corporation may prescribe. The list of incorporators and the Board of Directors follows.
