6 The name of the Corporation is MOUNTAIN MOVERS, INC.

7 II.

8 The period of its duration is perpetual.
9

10 III.

11 The purpose or purposes for which the Corporation is organ-
12 ized are: To engage in the business of common carrier, moving
13 and storage and the transaction of any or all lawful business for
14 which corporations may be incorporated.

15 IV.

16 The aggregate number of shares which the Corporation shall
17 have authority to issue is TWO THOUSAND (2,000), and all shares
18 are to be without par value, and of one class; only such dividends
19 shall be paid on an annual basis out of the Corporation's net
20 profits on the preceding fiscal year as the Board of Directors may
21 in their judgment deem it advisable to declare; however, if there
22 are no dividends in a particular year, any future dividends are
23 noncumulative.

27 necessary and proper for the accomplishment of any purposes, or
28 the attainment of any of the objectives, or the furtherance of any
29 of the powers hereinbefore set forth, either alone or in association
30 with other corporations, firms, or individuals, and to do every

2 of or connected with the aforesaid business or powers, of any
3 part or parts thereof; provided the same is not inconsistent with
4 the laws of Idaho under which this Corporation is organized.
