32 ARTICLES OF INCORPORATION - 1

I.

The name of the Corporation is MOUNTAIN MOVERS, INC.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the Corporation is organ-To engage in the business of common carrier, moving 13 and storage and the transaction of any or all lawful business for which corporations may be incorporated.

IV.

The aggregate number of shares which the Corporation shall have authority to issue is TWO THOUSAND (2,000), and all shares are to be without par value, and of one class; only such dividends shall be paid on an annual basis out of the Corporation's net profits on the preceding fiscal year as the Board of Directors may in their judgment deem it advisable to declare; however, if there are no dividends in a particular year, any future dividends are noncumulative.

The Corporation shall have the power to do everything necessary and proper for the accomplishment of any purposes, or 28 the attainment of any of the objectives, or the furtherance of any 29 of the powers hereinbefore set forth, either alone or in association 30 with other corporations, firms, or individuals, and to do every
