**ARTICLE I
NAME**

SECRETARY OF STATE
STATE OF IDAHO

The name of the Corporation is *Keenan Law, P.C.*

**ARTICLE II
DURATION**

The Corporation shall have perpetual existence.

**ARTICLE III
PURPOSE and LIMITATIONS**

The Corporation is organized for the purpose of practicing law, together with any lawful business subject to the statutory restrictions imposed upon professional legal corporations by the State of Idaho. Only attorneys, duly licensed and in good standing with the Idaho Supreme Court and the Idaho State Bar, shall be entitled to hold office, own shares or serve as a director of the Corporation.

**ARTICLE IV
CAPITAL STOCK**

The Corporation is authorized to issue 10,000 shares of no-par value common stock, which shall be designated "Common Shares."

**ARTICLE V
PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any additional stock of the Corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**ARTICLE VI
INITIAL BOARD OF DIRECTORS**

The Corporation shall have one director initially. The number of directors may be either increased or diminished from time to time by the Bylaws, but shall never be fewer than one (1). The following initial directors shall serve as directors until the first annual meeting of shareholders or until their successors be elected and qualify:

ARTICLE IX
LIMITED DIRECTOR LIABILITY

The personal liability for a director to the Corporation or its shareholders for monetary damages for breach of fiduciary duty as a director shall be limited to the fullest extent of the law as provided in Idaho Code Section 30-1-54(2), or its subsequent equivalent.

ARTICLE X
AMENDMENT

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the shareholders of the Corporation.

ARTICLE XI
AUTHORITY

Each director shall have authority to endorse, cash, deposit and negotiate all checks, cash and negotiable instruments on behalf of the Corporation.

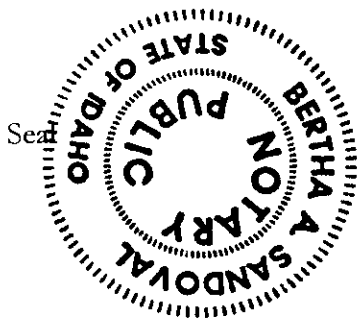
